

## PROCEDURE AND FORM FOR PERSONAL DATA SUBJECT APPLICATION

Pursuant to Article 11 of Law No. 6698 on the Protection of Personal Data ("KVK"), data subjects defined as relevant persons (hereinafter referred to as "Applicant") are granted the right to make specific requests regarding the processing of their personal data.

According to Article 13/I of the KVK, applications concerning these rights must be submitted to our Company as the Data Controller in writing or through other methods determined by the Personal Data Protection Board ("Board").

- Learn whether your personal data is being processed,
- Request details about the information we collect,

- Request correction, updating, or deletion of data if processed incompletely or inaccurately, including notification to third parties to whom data has been transferred, should the reasons requiring processing cease to exist.
